

Business Select

Service description

Business Select is a call plan open to all Centrex business customers (see exclusions below), for a monthly fee the customer is eligible for:

- 2.00p per minute to regional & national directly dialled destinations.
- Reduced charges for calls made to mobiles.
- A 20% discount to all other international destinations, including international mobiles and international ISDN calls.
- 5 nominated international destinations to receive a 35% discount on call charges, including ISDN calls (excluding international mobiles)*.

EXAMPLE: Customer calls France and automatically receives 20% discount as part of this scheme but this country is also listed as one of their nominated countries so an additional 15% discount is applied giving a maximum of 35% discount to the standard charge.

- PLUS the option to choose a further 5 or 10 countries to receive 35% discount for a nominal fee of £2.00 or £3.50 per month not including international mobiles.
- Business Select is applicable on a per customer basis.
- All other call charges including local calls will be at standard rates.

Terms & conditions

- The scheme is open to customers spending up to £5,000 per annum exc. VAT on non-local calls.
- Customers will pay an initial fee, which will apply up to the next date of payment of their annual rental and will be equivalent to the annual fee pro-rata.
- The lines to which customer-based discount schemes apply must be classified as business lines and rented from KCOM by the customer or the customers wholly owned subsidiaries.
- Calls from the following lines rented from KC by the Customer are excluded from Business Select: Residential Lines; Payphone lines; Temporary Lines / Temporary Service Lines; Lines not provided by KC.
- This scheme specifically excludes KC Local numbers and calls to non-geographic numbers (i.e. those numbers starting 07, 08 or 09). It also excludes calls made using an Operator or a Charge Card. Similarly, calls to Directory Enquiry Services and all other Operator Services do not apply.
- Each international destination (including international ISDN calls) nominated for Business Select will be registered against a position between 1 and 15. Customers are only able to change the Destination/Country in each position once every month.
- For a nominal fee customers can choose countries in further multiples of 5 countries up to a maximum of 15 countries in total. Although discounts are grouped into multiples of 5, less than 5 destinations can be selected. The full charge for each scheme is still applicable.
- Discount is only applicable to the countries listed and calls to international mobiles are excluded.
- Calls to regional & national, UK mobile and international directly dialled destinations will incur a call set-up charge of 10.00p. All other calls will incur a minimum charge of 5.50p.
- All Calls will be billed on a monthly basis under this scheme.

*Calls to the following cannot receive further discount above 20%:

- Cook Islands, East Timor, North Korea, Niue Islands, St Helena, Sao Tome & Principe, Tokelau, Tuvalu, Wallis & Fortuna
- Countries with specific International Mobile Rates
