

KCOM Business Packages

1. Introduction & summary

KCOM Office packages enable customers to combine their fixed voice and broadband products on to one consolidated monthly bill. Six options are available to the customer depending on their business requirements. For an additional charge customers can also choose to add a mobile or smartphone to their package. 2. Service description

Based on ADSL technology, KCOM Broadband provides internet access with connection speeds that vary, depending on your line length from the telephone exchange.

2. Contract Term

The standard contract length is 24 months for KCOM Business Packages. Flexible contract options are available for an additional charge, and Early Termination Fees apply. Please see Service Options and Additional Charges sections of this document.

3. Pricing

Prices below are inclusive of VAT. Discounts are available for payment by Direct Debit and Online Billing, both of which provide convenience and control to our customers.

6. Additional charging information

Fixed broadband additional usage charges

£0.85 Ex VAT (£1.02 Inc. VAT) for every GB or part thereof.

Upgrade & downgrade fees

There are no upgrade charges. As any downgrade will be effectively a cancellation of a service, the early termination charge will constitute the “downgrade” fee.

7. Service termination & charging

Where a customer serves notice within the initial contract period to cease their package and does not retain any element of that package, appropriate early termination charges based on the remaining duration of their contract will apply. These will be calculated as the line rental charges related to the remaining duration of the contract – for instance a customer who has the KC Office Local package and pays by Direct Debit with 6 months remaining = 6 x £45 = £270.

Where a mobile bolt on is ceased within an agreed contract, appropriate early termination charges based on the remaining duration of their contract will apply. For instance a customer who has 6 months remaining = 6 x £35.00 = £210.00

Where a customer cancels their package contract but retains a fixed line, early termination charges are calculated as follows:

Where the customer ceases their package but retains any of the services which are part of their original package, they will commence a new 12 month contract for that service.

Where a package is outside of the initial contract period and is being fully ceased, a thirty day notice requirement will apply, after which no additional charges will be raised.
